1. Background Information

1.1 Project Background

The project has been operational in Kenya since July 2004. Its is housed by the Ministry of Environment and natural Resources, National Environment Management Authority (NEMA).

1.2 Report Background

This report covers the project implementation at the national level during the period January- December 2008. It highlights the achievements and outputs per component as well as the constraints, recommendations and lessons learned during the period.

Project context as it affected project implementation

2. Project Context

2.1 External context

This year 2008 the microgrant program was more focussed on Wetlands conservation activities and linkages with the other institutions like Sio-Malaba Malakisi basin project to provide synergy to the micro-grants activities and more so to facilitate a process of possible scaling up of piloted activities. The period as well experienced the close collaboration with government departments and as well as other civil society organizations like the Kenya Nile Discourse Forum.

2.2 Internal Context

This year experienced significant delays in processing and receiving fund for both office running and activities, this affected national level implementation. The Country Operating budget for the microgrant was not received this year 2008, the host institutions didn't renew the contract, and this has forced the project office to relocate to UNICEF offices and to operate without funds for the whole year. This has serious effects on the program quality and meeting of targets, for the year.

3. Actual Results

During this period, the following was achieved:

Outcome 1: Strengthened Institutions for Regional Cooperation:

- Successfully concluded NTEAP 5TH PSC and work planning in Mwanza Tanzania attended by LMGC and NPC
- Linkages with other NBI projects strengthened through participation in NBI national coordination meeting

- NPC, counterpart, Chairman teachers Network, and Wetlands WG member trained in results –based monitoring
- 2 new NEPS approved for funding and implementation started
- Successfully participated in the National Nile Day celebration in cooperation with NBI national Office and other NBI projects
- Participated in successfully completed Nile Basin Development Forum in Khartoum in the period 17-19 November
- Finalized the Macro-sectoral Policies study

Outcome 2: Improved capacity of the communities of the project areas to demonstrate viable approached to land, forest, and water management

- 3 new microgrant projects started and funded to tune of \$75,000
- 26 projects operational funded to the tune of \$623,954
- Community capacity enhanced in microgrant implementation process and awareness created
- Evaluation done by consultant and recommendations received
- Auditing done by Price Water House coopers for 8 projects and weaknesses and strengths were highlighted
- Project monitoring carried out by LMGC
- 3 articles contributed and published in the NTEAP newsletter
- LMGC and 3 grantees attended Lake Victoria Wetlands Stakeholders meeting to build a network for conservation of wetlands
- LMGC attended institutional capacity building for sustainable consumption and production for the Lake Victoria basin resources organised by Kenya Cleaner Production Center and SIDA
- LMGC and 2 women grantees capacity built in fundraising, gender mainstreaming and formed a regional womens' network
- World Bank Mission visited 6 projects and made recommendations

Outcome 3: Environmental Education Improved and Public Awareness Enhanced

- School awards successfully completed with one Kenyan student winning a Regional award
- National working group meeting held and decided to host the National working group under NEMA, where they would join the national ESD steering committee
- Nile Environment Awareness Week was held between 27th 30th June,, 2008 focusing on the sustainable use and conservation of wetlands. Two wetlands were selected for demonstrations in Kitale and Bungoma and 8,500 trees were planted

to protect the wetlands. A Student and teachers exchange was also carried out to teach and expose students to practical aspects of wetland conservation

- Awareness materials developed for use in Nile Week
- Twenty teachers were trained on use of e-learning materials.
- Teacher association formed Kenya Environmental Education Teachers Association (KEETA) and will sustain NTEAP outputs
- Regional Journalists workshop held and amalgamation modalities agreed on.

Outcome 4: enhanced capacity for conservation and management of wetlands and biodiversity

- 2nd regional working group meeting attended by two participants from Kenya
- 1 national working group meeting was held and agreed expansion to include more institutions working with wetlands in Kenya
- Meeting held for 2 biodiversity groups mammals and invertebrates who agreed to work on improving the baseline
- 2 candidates benefited from sponsorship to attend the wetland international training at Kenya Wildlife Services training college in naivasha
- The Process to develop a transboundary Wetlands management plan for Sio-Siteko started and will be completed early next year.

Outcome 5: Increased capacity and awareness on Water Quality Monitoring in the NB countries

- 2 Participants trained on water quality monitoring regionally
- Procurement of Simple WQ Kits completed and delivery expected to be complete by end of the year
- Procurement of selected Laboratory equipment for Kisumu is completed and delivery is in the process and will be completed by end of the year.
- Second biological monitoring training successfully held in Kisumu with 12 participants benefiting from across the basin.

4. Project Management

Some institutional arrangements are in place at the national level to help in activity implementation and sustainability of NTEAP outcomes. These include:

NPC Counterpart: Has been appointed and briefed to support sustaining of NTEAP outcomes in the Host institution and coordinate interlinkages with other Ministries..

Expanded ESD committee: This was established to include the National EE working group members who will continue to highlight Nile basin EE issues at National lelve and participate in the DESD.

Teachers Association: The Kenya Environmental Education teachers Association was formed and registered to continue the achievements of NTEAP schools projects.

All other project management structures are still in place to support the NPC and LMGC to implement national level activities.

6. Challenges and constraints

- The fund request and transfer processes, caused significant delays in processing and receiving of funds for national level implementation.
- Office running expenses were not received at all by the LMGC office and inadequate funds were received by the NPcs office
- The low capacity of NGO/CBOs has made it very challenging to not only receive substandard both narrative and financial reports which take time to be revised for eventual subsequent disbursement of funds, but as well quite challenging during implementation.
- Delay in disbursement process provide a cut off period during which grantees may not be implementing, thus when they receive the money then it's like they start all over again.

7. Lessons Learned and recommendations

- Projects with direct livelihoods activities seem to attract attention of many community members some of which may develop grudge/jealousy with the implementing CBO and thus bring conflicts and acrimony. (Two of the fish farming projects funded have experienced direct conflict with some disgruntled community members)
- Group monitoring of projects would need thorough understanding of various projects milestones and more so the specifications in design and agreement to avoid generalizing output based solely on tangible outputs.
